What courses are included in the Summit? What material is covered?

The 3 day virtual Summit will be led by live instructors and includes IBBA courses #210 (16 credit hours) and #220 (8 credit hours). Afterwards you will also be given access to the online/ondemand course #221 (8 credit hours) through IBBA's learning portal, IBBA University (IBBA-U). Who are the instructors?

BBF Members, Ryan Cave and Brian Stephens, will be instructing. This will bring a Florida-centric dimension to the classes that you won't find in standard IBBA Summits.

How much does it cost?

The standard IBBA Summit price is \$799.00. But with the \$100.00 subsidy from BBF your cost will only be \$699! You won't find an opportunity to attend a Summit at a better price.

What are the cancellation and refund policies?

Registration and cancellations are managed by the IBBA in accordance with their standard policies. Make sure you read all the terms and conditions when you register.

What are the class attendance requirements?

The IBBA upholds strict standards for its courses. Full attendance with an operational camera that is on for the duration of each day is required to earn credit. Students are expected to be in a quiet place with no verbal or visual interferences and are prohibited from taking phone calls during class. You will be mailed your course materials and are expected to have them for reference during the course. Each course also has an exam that you must pass to earn credit. Do these courses qualify for the IBBA's Certified Business Intermediary (CBI) designation?

Yes! In fact, they are part of the required coursework to obtain the CBI. If you are interested in pursuing the CBI, you have the option to register for the CBI Bundle which includes not only the Summit but also everything else you need to obtain the CBI, including a Conference Pass to the IBBA's 2025 Conference in Orlando.
